Sanjeeb Sapkota welcomed everyone and started the meeting highlighting the current projects including the NCC project that is under way.

Sagun brought up the topic of minimizing the duration of the meeting by shortening the time taken by each person using the 5 minute allotted per speaker with extra 2 minutes to wrap their statement.

Sanjeeb Sapkota talked about the need to start looking ahead for the 2013 Convention so that it will be a successful convention.

Dhana Timilsina talked about the activities started by the Entrepreneur Comm, which included the task of tapping the resource we have by creating a database of all the workers that could be utilized in the future for NASEA's purpose.

For the task of choosing a representative from NASEA to NRN it was suggested that Dhana Timilsina be reinstated however there was a motion on the floor to see if other candidates could fill this position instead of it being given to same person every year.

Kumar KC and Dhana Timilsina brought up a topic about the possible reimbursement for travel cost related to NASEA. This will have to be further looked upon and was pushed back for more research. Sanjeeb and Dhana brought up the topic of Dual Citizenship and the push by NRN to achieve it.

Dipendra Thapa brought up the topic of NCC and if NASEA was ready to support it by taking 50% of the amount in loan (\$250K). Due to the legality issues as well as NASEA's unavailability to support the payback of loans since NASEA doesn't have income it was decided that this was a risky prospect instead donation method was suggested. Voting took place at which all the members decided that donation was the preferred method to go forward with the NCC from NASEA's side.
